**WHEREAS:** The School Committee wishes to better communicate with the residents of Cumberland regarding activities and news concerning the school department;

**WHEREAS:** The School Administration has interviewed numerous candidates to provide these services;

**NOW THEREFORE, BE IT RESOLVED BY THE CUMBERLAND SCHOOL COMMITTEE OF THE TOWN OF CUMBERLAND RHODE ISLAND AFTER DISCUSSION & VOTE AS FOLLOWS:**

**SECTION 1:** The Cumberland School Committee hereby empowers the Superintendent of Schools to execute a contract with the successful candidate, Justin Martin of Upton, MA for a contract of \$2,000 per month, not to exceed \$12,000 through June 30, 2013.

**SECTION 2:** THIS RESOLUTION SHALL BECOME EFFECTIVE IMMEDIATELY UPON ITS PASSAGE BY THE CUMBERLAND SCHOOL COMMITTEE
