
NOW Therefore, Be it Resolved that the Cumberland School Committee after Discussion and Vote:

Quality Improvements	\$76,866

The maximum amount that you could have paid under MICPA for Option #1 is \$231,431 and for Option #2 is \$88,261. However, based upon local market pricing, we propose to complete this project for **\$167,202 for Option #1 and \$62,016 for Option #2**. Potential issues that could arise during the construction phase of the project will be addressed via unit pricing for additional work beyond the scope of the specifications.
